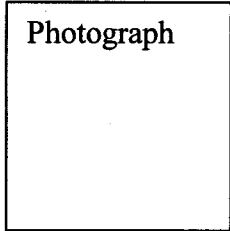

CONDITIONS OF SUPPLY

1. The water (undertakes) rules and water (general) regulations (sub.Leg.L.n. 78/1962) as from time amended shall be deemed to be incorporated in and to form part of these conditions of supply.
2. Application for the execution of works will as a rule, be dealt with in the order of priority of date, but the water undertakes reserves the right of executing the work in the manner and at the times best to his convenience.
3. All charges shall be payable on demand.
4. If any account is overdue the water supply shall be cut off under the provision of the water (undertakes) rules (cap.2002 sub Leg) and proceedings taken to recover the charges due.
5. Any changes in the charges shall be notified in the gazette, and in addition details thereof shall be sent to each consumer with the monthly account preceding such charge.
6. Without prejudice to any antecedent right against the consumer including the right to take proceedings
 - a). No consumer shall use permit to be used any water supplied in pursuing of an application made by him under regulations 3 of these regulations except for such use as specified by him in his application.
 - b). No consumer shall convey, or permit to be conveyed by any means whatever for use outside is plot or for Sale any water supply to him by water undertakes.
7. All consumers agreement forms must be indicated the conditions of supply the water (under takers rules and water) General regulations states clearly as follows; Construction, Domestic use, Commercial premises, Lodging, Bars, Hotels Institutions, the water deposits and charges are different and to be followed as Per tariff states.
8. In accordance with the regulations 12 of these regulations, the consumer shall deposit Kshs2, 500/= which shall be retained by the water undertaker for the period during which the consumer is supplied with water.
9. The consumer shall meet all charges in respect of water supplied of pursuance of this application and consumer's pursuant to a written request made by him.
10. The consumer's responsibility begins immediately after the meter towards his house irrespective of the length of pipeline financed by him.
11. It is the responsible of the consumer to give access to the meter and premises to the water undertaker or his authorized agent who shall reserve the right to disconnect in the event of no such access being granted.
